### Flyspot technical data

Flyspot Wind Tunnel is state of the art, based on the newest evolution of Indoor technology

- Indoor Skydiving Germany Technology
- Top speed: 320 km/h – Flyspot is currently the fastest wind tunnel in the world
- 14 feet diameter, 50 feet (17 metres) high octagon flight chamber. Glass part 4.5 meters high.
- Reinforced concrete structure makes it extremely quiet, powerfull and smooth
- Patented air exchange based tunnel cooling system allows for continous operation regardless of external conditions and give us full control of temperature in the tunnel ensuring a comfortable environment for the athletes. We guarantee there is no temperature problem in the Flyspot Wind Tunnel.
- Our tunnel is so quiet we are unable to measure its noise level as it is below that of the environment.
- Free and fast WiFi at the tunnel and all other competition venues

### Event facilities

At Flyspot:

Registration will be conducted in the large lobby equipped with 3 networked computers and a fully integrated modern and customised system, capable of handling all accounting and tracking. Judging panels will be housed in three large private offices with ample space for the judging teams, video playback monitors, printers and all necessary supplies.

An electronic image dubbing area should not be necessary as all flight chamber video is automatically transferred immediately to a video server from which the files can be accessed or transferred.

### \*Accompanying persons

The registration fee for additional accompanying persons, who are not a part of the official delegation or require a sanction fee to be paid, will be 200 EUR and will include lunch on the days of the competition, Opening Ceremony, Awards, Closing Ceremony, social events and entertainment.

### Entry Fee includes

Competitor entry fees include 3 minutes of training time in the Official Practice Period, Opening Ceremony, Competition costs, lunch each day during the competition (October 12-15), Closing Ceremony and social events, entertainment, promotional/gift selections, discounted pre-event flight time.

Entry fee for Heads of Delegation, Team Leaders and Other Delegation Members includes the Opening Ceremony, lunch each day during the competition (October 12-15), Closing Ceremony and social events, entertainment, promotional/gift selections.

Transport from and to the airport will be supplied by Flyspot as a shuttle service as a part of the entry fee. Please email [alicja@flyspot.com](mailto:alicja@flyspot.com) details of your arrival and departure (airport name, date, time, airline, flight number and amount of people).

## 8. PRE-EVENT TRAINING

As stated in the bid, the Tunnel will be available for all competitors for almost 2 weeks before the event date for 450 EUR/h and can be booked any time between registering and the start of the competition. The minimum time that can be purchased is 10 minutes. 3rd Flyspot Open and Polish Championships will be held **29-02.10.2016** and is open to all participants and is a perfect opportunity for training.

## 9. REGISTRATION

The Competition rules and FAI Sporting Code, Section 5, paragraph 4.10 regulate the number of teams allowed in each event. Therefore each FAI Member country may register up to:

**\*JUNIOR** (FAI Sporting Code – Section 5: 1.1.2 Definitions: 10): ... For the purpose of all indoor skydiving disciplines, a junior competitor is a person under the age of 17 or whose 17th birthday occurs during the calendar year in which the relevant competition takes place.

**MINIMUM PARTICIPATION** (Sporting Code – Section 5: Chapter 4: Organisation of Competition: 4.10):

Where less than 4 NACs are entered in an event (see Competition Rules – SC5 4.2) at an FCE, the

Sporting Code, GS 4.4.3.1 permits the IPC to determine whether the event will take place and whether the title of Champion will be awarded.

(1) Six months before an FCE, the relevant IPC Committee must determine the number of NACs intending to enter a team or individuals in an event at the FCE. If the relevant IPC Committee determines that less than 4 NACs have this intention, the event will not take place. The Committee will inform the IPC Bureau of this and the IPC Recording Secretary will send out an information notice within seven days to the FCE Organiser, IPC Delegates and NACs that the particular event will not take place and will arrange for its publication on the FAI/IPC website.

(2) If 4 or more NACs indicate an intention as per (1) to enter a Delegation to a WPC or Continental Regional Championship but less than 4 NACs make an official entry and participate, the event will take place, and the title of Champion (excluding the words World and Continental) will be used. The same provision regarding entries applies to any other FCE, where the title of Winner is always used.

(3) An event will be removed as a valid event from the IPC Competition Rules, if:

- (a) The event does not take place at two successive FCEs by reason of (1) above.
- (b) The event has less than 4 NACs participate at two successive FCEs.
- (c) In two successive FCEs, the event has less than 4 NACs participate or less than 4 NACs indicate the intention to participate as per (1) above or a combination thereof.

**REMINDER** (*Sporting Code – Section 5: Chapter 4: Organisation of Competition: 4.4.2*)(4):

...Where the Competition Rules provide that a Delegation may consist of more than one team or competitor for a particular event, each team or competitor shall compete on equal terms and conditions.

**The NAC, by including a team or competitor in the Delegation, certifies that each team or competitor is qualified and competent to participate in the event(s) entered.**

## 10. PROCEDURES FOR REGISTRATION

Registration for the 2<sup>nd</sup> FAI World Cup of Indoor Skydiving 2016 will be **online** at [www.wcis2016.com](http://www.wcis2016.com) starting 06.06.2016 (6<sup>th</sup> of June 2016):

### **STEP 1**

#### Provisional Entry

Each NAC will receive an email with log in details/link to the online system.

A NAC's representative with the status of "Super Admin", must login online to complete the Provisional Entry and enter the following information:

- Amount of teams in each discipline/event
- Name of each team, Team Captain's name and email (this will be used to generate logging details for each Team captain)
- Names, birthdays and FAI sporting license numbers for each team member
- Indication of team members participating in more than one event

### **STEP 2**

Once all the information has been submitted to the system, the NAC representative will close the entry and generate the pdf. The PDF document needs to be signed by the NAC and uploaded using the system.

**Deadline for Provisional entry: 27.07.2016 (27th of July 2016)**

### **STEP 3**

#### **Final Entry**

Based on the information submitted, each Team Captain will receive log in details to the system (via e-mail). After logging in, will be required to update and submit the following details:



- 
- Contact details for each team member
  - Tshirt size
  - Training flight bookings

Once all details of team members have been finalized, Team Captain/Team Administrator will have to pay online using either a credit card or PayPal account. An invoice will be generated automatically.

**Deadline for Final entry and payments: 27.08.2016 (27th of August 2016).** Final entries will be accepted within 72 hours of the Provisional entry reaching the Organizer.

Should there be any changes to the number of teams or team members, the change can only be made by the NAC Representative (Super Admin).

**Late registration: 01.09.2016 (1<sup>st</sup> of September 2016).**

Late registration after 1<sup>st</sup> of September 2016 may be accepted only if capacity allows. The registration fee will be increased by 20%. Sanction fee will remain unchanged.

## 11. FAI SPORTING LICENSES

A valid FAI Sporting License for 2016 is required and must be obtained through the Competitor's NAC. All competitors must be registered by their NAC in the FAI Sporting License Database ([www.fai.org](http://www.fai.org)) before submitting the Official Entry Form to the Organizer.

## 12. ACCOMMODATION

Flyspot has pre-reserved all rooms at Rest Hotel for participants of the event at discounted rates. Rest Hotel is located 10 m from the tunnel.

**Once the team has registered and registration fees have been paid, the team will receive a booking code. Booking can be done via e-mail and instructions will be supplied.**

Once all rooms are fully booked at the Rest Hotel, other competitors can be placed in the Mazurkas Hotel located 4 km from the tunnel. Flyspot will supply shuttle transport.

Accommodation at Rest Hotel (10 m from Flyspot) per room:

Single room: 141 PLN (weekend) - 176 PLN (weekdays)  
2 persons sharing/night: 154 PLN (weekend) - 194 PLN (weekdays)

## 13. SAFETY INFORMATION & REQUIRED EQUIPMENT

All participants are required to wear a helmet and equipment which is in compliance with Sporting Code Section 5 – 2016 Edition V2.0 <http://www.fai.org/downloads/ipc/SC5>

Parachutes, Mock Parachute Containers or "Dummy Rigs"

- Are not permitted inside the flight chamber at any time.

Metal on Helmet

- You may not enter into the wind tunnel with exposed metal components.
- If you enter into the wind tunnel with exposed metal despite this warning, the Organizer may hold you financially responsible for any damage to the wind tunnel equipment.

#### Plastic Helmet Mounts

- It is recommended that any plastic camera mounts are removed from your helmet before entering the flight chamber.
- Should your helmet have any plastic mounts and you fully understand your own risk in flying with foreign objects, it has to be approved by a designated Flyspot instructor. In addition Flyspot requires your written acknowledgement and your agreement to do so at your own risk.
- Flyspot reserves the right to prohibit you from entering into the flight chamber with any plastic helmet mount.

#### Weight belts

- It is recommended for competitors to bring their own weight belts. Flyspot has a very limited amount of rental weight belts.

## 14. INSURANCE, WAIVERS AND DOCUMENTATION

- Personal Health insurance, repatriation, and third party liability coverage are the responsibility of each participant and are highly advisable. Any injury or damage is the responsibility of the participant.
- Any damage to hotel rooms etc. is the responsibility of the persons involved.
- Personal items and equipment are the responsibility of each participant.

## 15. EMERGENCY MEDICAL SERVICES

The Organizer will have a full time first aid and CPR trained person on site for the duration of the event. Full ambulance and medical services are available through 112 emergency services. There are several hospitals and medical centers in close proximity.
