## 1. General

The FAI World Aerobatic Championships (WAC) 2013 is organized by World Aerobatic Championships 2013, Inc. (aka WAC2013, Inc.) in cooperation with the cities of Denison, Sherman and Pottsboro, Texas.

### 1.1 Venue

The 27th FAI WAC 2013 will be held at the North Texas Regional Airport, Denison, Texas (KGYI). The towns of Denison, Sherman and Pottsboro are located in the county of Grayson County, a subtropical region just 112 KM north of Dallas.

The area is characterized by historical sites, casinos, shopping and Lake Texoma which offers boating, fishing and water sports.

There are two international airports: Dallas (KDFW), located south of Denison, and Houston (KIAH) , located further southeast. Dallas provides convenient international air freight and passenger service as does Houston. Houston provides on of the largest ports in the USA.

## 4. Regulations

### 4.1 Rules

The 27th FAI World Aerobatic Championships 2012 will be organized in accordance with the following rules:

- FAI Sporting Code, General Section
- FAI Sporting Code, Section 6, version 2013
- Aresti Aerobatic Catalogue (condensed) for Power Aerobatics – available through the website of Aresti System S.L. at [www.arestisystem.com](http://www.arestisystem.com)
- Regulations issued by the Federal Aviation Administration (FAA) USA
- Local Regulations

### 4.2 Official Language

4.2.1 The official language of the 26th FAI World Aerobatic Championships 2013 will be English.



## 5. Participation, Competitors and Aircraft

### 5.1 Participants

5.1.1 All FAI member National Airsport Controls (NACs) may be represented in the 27th World Aerobatic Championships 2013 by a team and/or individual competitors and observers.

5.1.2 Competitors must be members of their related National Airsport Controls (NAC).

### 5.2 Non – NAC Entries

Organisers accept entrants classified according to Sporting Code, Section 6 – 1.2.4.4. as “ Hors Concours (H/C). The Organizers require H/C applicants to provide evidence of appropriate and current Unlimited level aerobatic experience.

The Organizers may limit the number of H/C entrants depending on the number of NAC competitors that enter the Championships. Priority will be given to H/C applicants based on the date the Organizers received a valid entry form and a fully paid entry fee from each applicant.

### 5.3 Competitors

5.3.1 All pilot – competitors have to hold:

- Valid Pilot's License with authorization for aerobatics
- Valid Medical Certificate
- Valid FAI Sporting License
- Valid Personal Insurance policy

5.3.2 These documents must be presented upon registration (check-in).

### 5.4 Aircraft

5.4.1 Each aircraft participating in the competition must have a valid Certificate of Airworthiness for unlimited aerobatics. A valid aerobatic certificate of airworthiness or equivalent document issued by the competent aviation authority of the participant's country must be produced to the organizers for every contest aircraft. (FAI Sporting Code 1.2.6.1)

5.4.2 Each aircraft must have a Certificate of Insurance against Third Party Legal Liability (1 million USD). The Certificate of Insurance must cover the aircraft for use in an aerobatic competition.



5.4.3 Fuel will be supplied by the organizer:

- AVGAS: 100 LL
- Engine Oil: Shell W 100 and W 120
- Smoke Oil

## **6. Team composition**

### **6.1 Competitors**

Team composition will be according the Sporting Code, Section 6 – 1.2.4.1.a.

### **6.2 Officials**

The officials, as defined in FAI Sporting Code, Section 6, may enter as the National Team members.

### **6.3 Observers**

The relatives and other associates of competitors are accepted as Observers of the National Team. The entry fee for observers is different than for regular team members. (See fees on the next page.)

#### **Entry Fee covers:**

- Accommodation between October 8th and October 19th (11 nights) in hotel. Reservations will be secured for you at Tanglewood Resort. You do not need to make your own reservations.
- 3 meals per day.
- Fuel (AVGAS 100 LL) and engine and smoke oil for competition flights.
- Daily transfer between hotels and North Texas Regional Airport, Denison, Texas (KGYI).
- FAI Sanction Fee.

### 7.2 Deadline for entries

7.2.1 Deadline for Preliminary Entries: 30 March 2013.



7.2.2 The official entry forms together with Entry Fees and Participants Questionnaires are to be received by the organizers not later than 31 August 2013.

- A copy of a Certificate of Airworthiness Review and/or any Operating Limitations.
- Insurance documentation for the aircraft.
